- I. Reports – Review of 2017-2018:
 - A. Intermountain Financials reviewed by Jessica Hogg / Julia Ward
 - Total Income: \$11,407.17
 - Net Income: \$7,127.12
 - B. Report out of '17-'18 Events – Karen Homa reported on all IMF events and reviewed considerations:
 - No two events on the same day at different locations (difficult to staff)
 - Collaborate with other divisions to coordinate 18-19 schedule to benefit athletes/event hosts, allowing IMF teams to support IMF events
 - Data analysis to be conducted by Karen regarding some IMF athletes obtaining more points outside division. (Judge bias/ point spread)
 - Consider holding less events to have more training time (as recommended by Ski Congress)
 - Safe sport training every 2 years for coaches, officials and volunteers
 - TD event report due within a week after event, send to IMF Chair and Officials Chair
 - Lake Placid Judges Clinic A, October 11-14 '18

 - A. IMF Trailer – Review of Inventory List, all in agreement not to split the trailer and continue to manage it via teams/ chair
 - B. IMF Bibs – 250 bibs needed, will be seeking sponsors

 - E. Review Officials Compensation- Karen Homa Presented -Currently no standardized division policy – Looking to potentially adopt FIS standards (per diem, mileage etc., may add exceptions for shorter devo/air events) Proposal to be presented at next board meeting
 - F. Official Guidelines – Karen Homa informed the Board she has put together an IMF Officials Guideline to set standards – sets responsibilities of people involved in events, sets compensation for Officials and TD, sets Code of Conduct – Draft of the Guideline to be sent out to the Board for review and comments
 - G. Judge, TD Training, attracting volunteers- Continued need to advertise and communicate need for more volunteers, judges and TD's, IMF successfully trained and onboarded Chad Babcock as an IMF TD in the '17-'18 season.
